#### **TRICONSER TANK STORAGE : SOHAR & FUJAIRAH**

Triconser Group of companies has acquired in the beginning of April 2022 a tank storage facility of 9,000,000 BBL (almost 1.1 Million MT) in the port of Sohar at the Sultanate of Oman.

Additionally we have acquired tank storage facility of 2,000,000 BBL in the port of Fujairah in the United Arab Emirates.

The Board of Directors of Triconser Group of Companies came to the decision of acquiring a tank storage facility in Oman and UAE for various reasons:

- The oil and gas trading activities are executed from our office in Muscat, Oman.
- The port of Sohar and Port of Fujairah are the perfect hub between East and West.
- The Port of Rotterdam which still is the main harbor for our products situated in EU zone
- Tank storage managed by our logistic team gives us a lot of freedom towards our clients.

#### Sohar Port

Sohar is deep-sea Port and Free zone in the sultanate of Oman, managed by Sohar Industrial Port Company (SPIC), a 50:50 joint venture between the Port of Rotterdam and the Sultanate of Oman.

#### **Fujairah Port**

Port of Fujairah, also called Fujairah Port, is a deep port located in Fujairah, United Arab Emirates. It is the largest port on the eastern seaboard of the United Arab Emirates. The Port of Fujairah has a strategic location being connected to all the emirates within 300 km (190 mi) and located on the only eastern seaboard of the United Arab Emirates



#### TRICONSER TANK STORAGE : OMAN

Sohar port is situated midway between Dubai and Muscat, SOHAR saw its first vessel berth in 2004 and the adjacent Freezone was added in 2010. 2020 saw over 5,434 vessels call in SOHAR and the port now handles in excess of one and a half million metric tons of sea cargo each week. With multinational investments to-date of over US26\$ billion, it is one of the world's fastest-growing port and free zone developments and lies at the center of global trade routes between Asia and Europe.

#### Triconser tank storage in Sohar Port

The tank Storage is situated at the left side of the entrance with their own birth at the quay side.

The seaway entrance has a depth of -19 meters and at the birth there is a depth of -16 meters.

Triconser helds 4 tanks with the numbers CTTT-C61, CTTT-C99, CTTT-22 and CTTT-90 at the Oman Tank Terminal Company LLC with a capacity of 9.000.000 BBL or 1,1 Million MT.

The tanks are now ready for all kinds of products like EN590, D2, D6 and gasoline. For the storage of A1 jetfuel there will be done adjustments on our tanks done at the end of August 2022.
